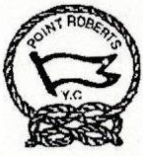

Point Roberts Yacht Club Waiver, Release of Claims and Indemnity

PLEASE READ. THIS AFFECTS YOUR LEGAL RIGHTS.

In consideration of Point Roberts Yacht Club (herein called "the Club") permitting me, my family, crew and/or guests to participate from time to time in the Club's racing programs and other events and to use its assets and premises (1) I hereby waive, remise, release and forever discharge the Club, its Board, Executive, Instructors, Members, Volunteers, Agents, Representatives and Employees from all and any claims, damages, liabilities, actions, causes of action and costs, including attorney's fees, existing at this time or at any time hereafter, arising out of participation from time to time of myself, my family, crew and/or guests in the Club's activities, including but not restricted to its racing programs, other events and the use of its assets and premises. (2) I hereby agree to indemnify and hold harmless the Club, its Board, Executive, Instructors, Members, Volunteers, Agents, Representatives and Employees from any and all claims, damages, liabilities, actions, causes of action or costs made by me, my family, crew and/or guests, including attorney's fees. The above waiver, release and indemnity shall be binding upon myself and my heirs, executors and assigns. (3) I agree to provide and maintain at my own expense adequate insurance coverage for the risks normally associated with participation in the above matters.
